6. <u>INSTRUCTIONS TO THE BIDDERS</u>

6.1 GENERAL INSTRUCTIONS

- 6.1.1 For the Bidding / Tender Document Purposes, 'Office of the Resident Commissioner, Government of Madhya Pradesh' shall be referred to as 'Client' and the Bidder / Successful Bidder shall be referred to as 'Contractor' and / or Bidder.
- 6.1.2 (i) While all efforts have been made to avoid errors in the drafting of the tender documents, the Bidder is advised to check the same carefully. No claim on account of any errors detected in the tender documents shall be entertained.
- 6.1.2 (ii) The bidders are advised to personally study the tender document and the services demanded and visit the location of MP Bhawan to acquaint himself first hand, the services required before bidding. Ignorance of any kind will not be entertained later on.
- 6.1.3 Each page of the Tender documents must be stamped and signed by the authorised person or persons submitting the Tender in token of his/their having acquainted himself/ themselves and accepted the entire tender documents including various conditions of contract. Any Bid with any of the Documents not so signed is liable to be rejected at the discretion of the Client. NO PAGE SHOULD BE REMOVED/DETACHED FROM THIS BIDDING DOCUMENT.
- 6.1.4 The bidder shall attach the copy of the authorization letter / power of Attorney as the proof of authorization for signing on behalf of the Tendering Company/Firm/Tenderer.
- 6.1.5 All Bidders are hereby explicitly informed that conditional offers or offers with deviations from the conditions of Contract, not accompanied with EMD of requisite amount/format, or any other requirements, stipulated in the tender documents are liable to be rejected.
- 6.1.6 The Bidding Company should only be a Limited / Private Limited Company/ Partnership Firm/ Proprietorship Company. Bidding in the form of JV Consortium is not permitted. Partner of partnership firm is allowed to participate in the own tender only.
- 6.1.7 The parties to the Bid shall be the 'Bidders' (to whom the work has been awarded) and the Office of the Resident Commissioner, Government of Madhya Pradesh, Madhya Pradesh Bhawan, New Delhi Shall be the client.
- 6.1.8 Technical specification are as given on Section-8 and he details of work is as per Section-9.

6. 2. EARNEST MONEY DEPOSIT:

- 6.2.1 The bid should be accompanied by an Earnest Money Deposit of ₹ 3,400/- (Rupees Three Thousand and Four Hundred only) in the form of Bank Demand Draft of any nationalized bank. The validity of the Bank Demand Draft must be at least up to 45 days starting from the date of submission of the bids. The Bank Demand Draft shall be in favour of Addl. Resident Commissioner, Government of Madhya Pradesh, Madhya Pradesh Bhawan, Chanakyapuri, New Delhi payable at New Delhi.
- 6.2.2 No request for transfer of any previous deposit of earnest money or security deposit or adjustment against any pending bill held by the Department in respect of any previous work shall be entertained.
- 6.2.3 Bidders shall not be permitted to withdraw their offer or modify the terms and conditions thereof. In case the bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid bid security in the shape of Earnest Money shall be forfeited to the Government.

- 6.2.4 The bids without Earnest Money shall be summarily rejected.
- 6.2.5 No claim shall lie against the Government / Department in respect of erosion in the value or interest on the amount of earnest money deposit or security deposit.
- 6.2.6 The bid security may be forfeited:
 - (i) If the bidder withdraws his bid during the period of bid validity specified by the bidder in the bid form; or
 - (ii) In case of successful bidder, if the bidder
 - (a) Fails to sign the contract in accordance with the terms of the tender document.
 - (b) Fails or refuses to honor his own quoted prices for the services or part thereof.

6.3. VALIDITY OF BIDS

- 6.3.1 Bids shall remain valid and open for acceptance for a period of 120 days from the last date of submission of Bids.
- 6.3.2 In case Client calls the bidder for negotiation then this shall not amount to cancellation or withdrawal of original offer which shall be binding on the bidder.
- 6.3.3 The Client may request for extension for another period of 60 days, without any modifications and without giving any reasons thereof.

6.4 PREPARATION OF BIDS

6.4.1 Language: Bids and all accompanying documents shall be in English or in Hindi

Documents comprising the Bid:

- a. Technical Bid Submission Form duly signed and printed on Company's letterhead (Section-4).
- b. Signature and Stamp on each page of the tender document.
- c. Contact Details Form, duly filled and signed (Section 4)
- d. Financial Capacity form -filled in signed and stamped (Section 4)
- e. Earnest Money Deposit of ₹ 3,400/-
- f. Cost of Tender form ₹ 200/-
- g. All attested supporting document in proof for experience.
- 6.4.2 Financial Bid: Financial Bid in the Price Schedule as provided in the Tender Document (Section 9). Shall be opened on the appointed date & time in the presence of qualified bidders/ their authorise representative, who chose to be present at the time of opening of financial bids.

6.5. SUBMISSION OF BIDS

- 6.5.1 Bidders sending their bids through courier should also ensure that their bids are received on the said address by the stipulated date and time. No time extension for couriers shall be granted.
- 6.5.2 Late Bids: Any Bid received by the office after the deadline for submission of bids, as stipulated above, shall not be considered and will be returned unopened to the bidder.

6.6 BID OPENING PROCEDURE

- 6.6.1 The Tender shall be opened in the Committee Room of the office of the Resident Commissioner, Government of Madhya Pradesh, Madhya Pradesh Bhawan, Chanakyapuri, New Delhi on 23/04/2021 at 15:30 hours by the Committee authorized by the competent authority of the office of the Resident Commissioner, Government of Madhya Pradesh, Madhya Pradesh Bhawan, Chanakyapuri, New Delhi in the presence of such bidders who may wish to be present or their representatives.
- 6.6.2 A letter of authorization shall be submitted by the Bidder's representative before opening of the Bids.
- 6.6.3 Absence of bidder or their representative shall not impair the legality of the opening procedure.
- 6.6.4 All the presented Bidders or their representative shall be required to sign the bid envelope to ensure the correctness of the bid.
- 6.6.5 Refusal to sign the bid envelope by the bidder or his representative, may disqualify his bid based on the decision of the Tender Opening Committee.
- 6.6.6 Bids shall be declared as Valid or Invalid based on the preliminary scrutiny, i.e. verification of EMD, by the Tender Opening Committee. However, detailed evaluation shall be done only in respect of Valid Bid.
- 6.6.6 Invalid Bids shall be returned on the spot, if the bidder or his representative is present.
- 6.6.7 The date fixed for opening of bids, if subsequently declared as holiday by the Government, the revised date of schedule will be notified. However, in absence of such notification, the bids will be opened on next working date, time and venue remaining unaltered.

6.7 RIGHT OF ACCEPTANCE:

- 6.7.1 The Office of the Resident Commissioner, Government of Madhya Pradesh, Madhya Pradesh Bhawan, Chanakyapuri, New Delhi reserves all rights to reject any bid including of those bidders who fail to comply with the instructions without assigning any reason whatsoever and does not bind itself to accept the lowest or any specific bids. The decision of the Competent Authority of the Office of the Resident Commissioner, Government of Madhya Pradesh, Madhya Pradesh Bhawan, Chanakyapuri, New Delhi in this regard shall be final and binding.
- 6.7.2 Any failure on the part of the bidder to observe the prescribed procedure and any attempt to canvass for the work shall render the bidder's bids liable for rejection.
- 6.7.3 The competent authority of the office of the Resident Commissioner, Government of Madhya Pradesh, Madhya Pradesh Bhawan, Chanakyapuri, New Delhi reserves the right to award any or part or full contract to any successful agency (ies) at its discretion and this will be binding on the bidders.
- 6.7.4 The Resident Commissioner, Government of Madhya Pradesh, Madhya Pradesh Bhawan, Chanakyapuri, New Delhi may terminate the Contract if it is found that the Contractor is black listed on previous occasions by any of the Government Departments / Institutions / Local Bodies / Municipalities / Public Sector Undertaking etc.

6.8. NOTIFICATION OF AWARD BY ISSUANCE OF "LETTER OF ACCEPTANCE"

- 6.8.1 After determining the successful evaluated bidder, Client shall issue a Letter of Acceptance (LoA)
- 6.8.2 The issuance of the Letter of Acceptance to the bidder shall constitute an integral part and it will be a binding to the contract.

6.9 RETURNING OF EARNEST MONEY DEPOSIT (BID SECURITY AMOUNT)

- 6.9.1 The Earnest Money Deposit of the unsuccessful bidders in the technical Bid evaluation stage shall be returned along with their unopened financial bids within seven (07) days after opening of financial Bids.
- 6.9.2 The Earnest money Deposit of the unsuccessful bidders in the financial bid evaluation stage shall be returned within seven (07) days, on award of contract to the Successful bidder.
- 6.9.3 The Earnest money deposit of all the bidders shall be returned along with their un-opened financial bids, in case of cancellation of Tender after the opening of Bids and prior to opening of financial bids.

7. GENERAL CONDITIONS OF CONTRACT (GCC)

7.1. **DEFINITIONS**

7.1.1 In this Contract including the Schedules the following words and expressions shall (unless the context requires otherwise) has the meaning assigned to them in this Schedule.

7.2. SECURITY DEPOSIT/ PERFORMANCE GUARANTEE

7.2.1 The successful bidder within 7 days of issue of Letter of Acceptance (LoA) shall deposit security deposit of 10% of contract value including earnest money through bank draft, which shall be returned only after successful completion of warranty period of three years.

7.3. COMMENCEMENT OF SERVICES

The Contract shall become legally binding and in force only upon:

7.3.1 The Contractor shall commence installation of Solar Hot Water Tank for Government of Madhya Pradesh within 07 days from the date of issue of acceptance and completed within 30 days.

7.4 TERMS AND CONDITIONS

7.4.1 EMD will be forfeited:

- i. If the offer is withdrawn/modified or alteration is sought during the period of validity of the offer or any agreed extension;
- ii. The agency fails to supply & installation of Solar Hot Water Tank.
- iii. If the agency backs out within 7 days after issue of Letter of Acceptance.
- iv. If the tenderer attempts to procure the contract by furnishing false/incorrect documents and by giving false declarations.
- v. Any other Act of the bidder which is tantamount to premature withdrawal from tender process.
- 7.4.2 The Empanelled Agencies will be required to submit the bills (in triplicate) of tax satisfactory completion of work efforts will be made for payment within 15 working days from the date of receipt of the bills.
- 7.4.3 Conditional tender shall not be accepted.
- 7.4.4 Guarantee/ Warranty: The Solar Hot Water Tank supplied against this order shall be warranted against any manufacturing defects for a period of 36 months from date of installation/commissioning. It shall be liable to rectify any defects that may be found in the material or due to faulty design or replace unsound material free of cost. The MS water tanks with all fixtures, fittings (PPR/CPVC/G.I./Brass/ i/c pipes & ball valve) including Bobbin heater, heating element, thermostat and temperature meter will be under guarantee/warranty of three year from the date of final installation and it has to be replaced, repair them at its own cost within 06 hours of intimation of such defect.
- 7.4.5 The cost of all types of fittings (PPR/CPVC/G.I./Brass i/c pipes and ball valves) to connect the new Solar Hot Water Tank to the old system will be borne by the contractor.
- 7.4.6 The contractor shall ensure immediate rectification of such complaints in the guarantee/warranty period, with-in twenty-four hours failing which a penalty of ₹ 500/- per day will be imposed beyond reasonable time and will be deducted from the cost of security deposit of the contractor.
- 7.4.7 In the event of total failure for providing services in the guarantee/warranty period, the Bhawan Authorities are free to hire services from the other service provider at the cost of security deposit of the contractor.
- 7.4.8 If the work is found unsatisfactory or of the firm dishonours the contract the job will be entrusted to any other firm/party at the risk/expense of the contractor.
- 7.4.9 All repairs and patch works shall be neatly carried out to match with the original finish. The contractor has to remove all the debris from the site of execution and dispose them at suitable places.
- 7.4.10 The supplier shall be invariably submitting the detailed technical literature/brochure etc. along with general and mandatory documents.
- 7.4.11 The lowest tender will be decided based on the Grand Total amount.
- 7.4.12 The Resident Commissioner, M.P. Bhawan reserves the right summarily to terminate the contract at any time without assigning any reason. In this connection, the decision of the Resident Commissioner M.P. Bhawan shall be final and binding on the contractor.
- 7.4.13 Time is the essence of the contract and work is required to be completed in all respects in 30 (thirty) days from the date of handing over the site
- 7.4.14 All the material must be indigenous and not imported.

 Solar Hot Water Tank capacity 2000 LPD made by 8mm MS sheet duly polished by anti-rusted epoxy paint with 07 nos. of MS socket for fitting of Bobbin heater and
- pipe lines with 50x50x6mm MS angle stand for tank duly painted by Red oxide and enamel paint. Complete in all respect.
- 8.3 Fixing SS 3kw Bobbin heater ISI mark.
- 8.4 Fixing Thermostats as per standard specification.
- 8.5 Fixing Temperature meter 4" dia. as per standard specification.
