- 1.2 Financial offer should accompany with requisite earnest money in the form of DD in favour of "Addl. Resident Commissioner, M.P. Bhawan, New Delhi".

- 1.3 Not more than one tender shall be submitted by a contractor or by a firm of contractors.
- 1.4 No two or more concern in which an individual is interested as a proprietor and/or partner shall tender for the execution of the same work. If they do so, all such tenders shall be liable to be rejected.

- 1.5 The **Resident Commissioner**, **M.P. Bhawan**, **New Delhi** shall be accepting officer here in after referred to as such for the purpose of this contract.
- 1.6 Application for issue of tender documents shall be submitted to **The Addl. Resident Commissioner, M.P. Bhawan, New Delhi** so as to reach the office not later than 02/11/2022 upto 03:00 PM.
- 1.7 The EMD must be deposited by an account payee bank draft of any scheduled bank drawn in favour of "Addl. Resident Commissioner, M.P. Bhawan, New Delhi" payable at New Delhi and must be submitted in a separate sealed cover along with the tender.
- 1.8 SECURITY DEPOSIT: The Earnest Money Deposit (EMD) of successful tenderer shall be retained and converted as Security Deposit. The successful bidder will have to deposit the prescribed Security deposit Rs. 5400/- (3% of the approved tender value) and to be paid in the form of Bank Draft to the "Additional Resident Commissioner, Madhya Pradesh Bhawan, New Delhi" payable in New Delhi. The Security Deposit is liable to be forfeited in case the bidder violates the terms and conditions of the agreement in any manner. The security deposit shall be released after successful completion of Comprehensive AMC period.

#### 3 <u>SCOPE OF WORK:</u>

Madhyanchal Bhawan is Government Guest House responsible for providing boarding, lodging and other related services to the constitutional authorities during their visit to Delhi. It has well organized rooms, lounge, restaurants and halls for providing the required facilities to the guests.

The work under the contract will include the Sand, Strainer, Sand Media, Activated Carbon, Resin, Multiple port Valve, Butter Fly Valve, Dosing Pump, Water Consumption Meter, PVC container, painting of softening plant and fittings etc., as and when required all accessories and all parts electrical/ non-electrical etc.

# 4 <u>TERMS & CONDITIONS: -</u>

- 4.1 AMC will be comprehensive, which will include
  - 4.1.1. Recharging plant by recharging salt (30 to 40 kg approx per recharge), chlorine etc. twice in a week by the contractor at its own cost.
  - 4.1.2. which include all spares/parts/existing operating systems and service charges transportation and taxes if any.
  - 4.1.3. Backwash, Recharging plant & Checking of water hardness once in a week by the contractor and submit the report to the MP Bhawan Authorities.
  - 4.1.4. Providing quarterly water testing report by Authorised Testing Lab.
  - 4.1.5. Replacement of Sand, Strainer, Resin (Na 225 Ion Exchange make), Multiple Port Valve, Butter Fly Valve, Dosing Pump, Water Consumption Meter and PVC container by the contractor at its own cost, as and when required.
  - 4.1.6. Painting of softener plant and related parts as per requirement of the client.
  - 4.1.7. The contractor must ensure to maintain and doing repairs to keep the plant in working condition at all time.
  - 4.1.8. Checking of Softener Plant & FRP Vessel once in a week and ensure to maintain and doing repairs to keep the vessel in working condition at all time.
- 4.2 The lowest tender will be decided based on the lowest quoted amount.
- 4.3 The contractor has to ensure the replacement of Resin (Na 225 Ion Exchange make/250 Ltr. approx) of softener plant at starting of the contract. Resin will be provided by the contractor.
- 4.4 The contractor must ensure round the clock telephonic contact at his residence and workshop etc. The complaints will be lodged by Sub Engineer or his representative to the contractor on his registered telephone or email. The contractor shall ensure immediate rectification of such complaints with-in twenty-four hours.
- 4.5 The Resident Commissioner, Govt. of M.P., New Delhi or his representative will have the right to inspect the existing work of the contractor before awarding the work.
- 4.6 In the event of any accident or major damage due to inadequate maintenance/repairs or negligence of the AMC staff, the complete compensation will have to be borne by the contractor and the Bhawan Authorities will not be responsible for any compensation (under various Central & State Acts, like Workmen's Compensation Act (Amendment) 2009, etc.) and repair/replacement of the equipment.
- 4.7 Monthly running payment will be made for AMC and no advance payment shall be given. Deduction shall be made for income tax, etc. as per rules.
- 4.8 Initially the agreement shall be executed for a period of one year and may be extendable for further period of one year's basis on satisfactory performance with mutual consent on the same terms and conditions.
- 4.9 The contractor shall supervise and maintain the equipment's directly or through his authorised trained staff without any assistance/resonance from Bhawan Authorities.
- 4.10 Only approved materials are to be used by the contractor.
- 4.11 The contractor must ensure that staff engaged by him are technically qualified for the job and bear good moral character and shall also be responsible for their good behavior and other deeds. The contractor shall arrange for obtaining security clearance/ verification

from proper authority of the person engaged by him and replace them if so asked by the authorities.

- 4.12 All old/unserviceable items required by the contractor due to replacement by New Items will be retained by the contractor and can be taken out of the premises only after obtaining written consent of the engineer-in-charge.
- 4.13 Conditional tender, tenders received without Tender Fee & EMD will not be accepted.
- 4.14 In situation where two or more contractors/ bidders are at par with each other in respect of their rates after all the arithmetic and other checks are carried out, then the rebate on the quoted amount from all the agencies whose rates are at par shall be invited, in sealed envelopes, which shall be opened in the presence of the agencies whosoever choose to remain present.
- 4.15 The bidder shall be solely responsible for any accident/medical/health related liability/compensation for the personnel deployed by it at Madhyanchal. The Madhyanchal shall have no liability in this regard.

## 5 <u>MINIMUM ELIGIBILITY CRITERIA: -</u>

5.1 The Bidder should have experienced in the annual maintenance of water softener plant/water treatment plant or erection of water softener plant in the Government Departments / Public Sector (Central or State) /Three Star Hotels / Guest Houses or equivalent in any three years during last Six years.

(Relevant documents i.e. copy of work order & received successful payment/transaction details or completion certificate to be submitted along with bid as documentary proof.)

- 5.2 The Bidder should be registered with GST portal and must submit the photo copy of provisional GSTIN registration certificate.
- 5.3 Photo copy of PAN Card.

## 6 <u>PENALTY: -</u>

- 6.1 A minimum penalty of ₹ 500/- per occasion will be imposed on the contractor for any inconvenience caused on accounts of the workman's dereliction of duty, disobedience of orders or shabby work performances.
- 6.2 The contractor must ensure round the clock telephonic contact at his residence and workshop etc. The complaints will be lodged by the Addl. Resident Commissioner or his representative to the contractor on his registered telephone or email. The contractor shall ensure immediate rectification of such complaints within 24 hours failure to which a penalty of ₹ 700/- per day will be imposed beyond reasonable time required for such repair of which the decision of the Engineer-in-Charge will be final & binding.
- 6.3 The contractor shall be liable to pay an additional penalty up to maximum of 6% of the contractor value or part thereof in the event of non-satisfactory performance of if it observed that services rendered are not up to the expectations or are delayed (normally). The decision of Resident Commissioner will be final and binding.
- 6.4 In the event of total failure for providing services within 24 hours, the Bhawan Authorities are free to hire services from the other service provider at the cost of contractor in addition to terminating the contract and forfeiting the security deposit.
- 6.5 A maximum penalty of ₹ 1000/- per day will be imposed on violation of any delay.

#### 7 <u>DISPUTE SETTLEMENT: -</u>

- 7.1 In the event of any dispute all matter shall be referred to Resident Commissioner, Govt. of Madhya Pradesh, M.P. Bhawan, New Delhi for arbitration, whose decision shall be final & binding.
- 7.2 All disputes arising out of or in any way connected shall be deemed to have arisen in New Delhi. Only the courts in New Delhi shall have jurisdiction.

#### 8 <u>TERMINATION OF CONTRACT: -</u>

- 8.1 The M.P. Bhawan will have the right to terminate the contract by issuing 30 days' notice if it is felt that the services rendered are not satisfactory or there is a delay in rendering service/ repairs. The Security Deposit shall be forfeited and all payments shall be with hold till closing of financial year/satisfactory repair of the equipment's.
- 8.2 In the event of total failure for providing services within 24 hours, the Bhawan Authorities are free to hire services from the other service provider at the cost of contractor in addition to terminating the contract and forfeiting the security deposit.

#### 9 <u>SINGLE STAGE TWO ENVELOPE SYSTEM: -</u>
