#### 3 SCOPE OF WORK

Madhyanchal Bhawan isGovernment Guest House responsible for providing boarding, lodging and other related services to the constitutional authorities during their visit to Delhi. It has well organized rooms, lounge, restaurants and halls for providing the required facilities to the guests.

The work under the contract will include the **supply**, **installation**, **testing and commissioning of air washer unit** conforming to these specifications and in accordance with requirements of schedule of quantities. The unit shall be installed on the same place; where the old air washerunit has installed.

#### 4. TECHNICAL SPECIFICATIONS

#### **AIRWASHER UNITS**

#### 4.1 SCOPE

The Scope of this section comprises the supply, installation, testing and commissioning of air washer units conforming to these Specifications and in accordance with requirements of schedule of quantities. The unit shall be installed on the same place; where the old air washer unit has installed.

#### 4.2 **TYPE**

The Air Washer Units shall be of draw thru type having various sections such as wire mesh filter section, with suitable thickness cellulose pad section, and fan section with centrifugal fan as per schedule of quantities. The air moving capacities shall be as shown in schedule of quantities.

#### 4.3 HOUSING/ CASING

The housing/casing of the cooling unit shall be of double skin construction. The frame work shall be of extruded aluminium hollow sections. All the frames shall be assembled using, pressure die cast aluminium joints to make a sturdy strong & self-supporting frame work for various sections. The construction shall allow disassembly of the various sections and easy re-assembly to enable easy transportation, shifting etc.25mm thick double skin panels shall be made of 0.6mm pre-coated green/blue colour sheets of GSS on outside and 0.6mm from plain Galvanized sheet inside with CFC-free PUF, 40 kg per CuM density insulation injected in between. These panel shall be fitted on the frame-work with soft rubber gaskets fixed in built-in grooves of Aluminium frame in between to make the joints air tight. Frame work for each section shall be jointed together with soft rubber gasket in between to make the joints air tight. Suitably air tight access doors/panels with nylon hinges and lock shall be provided for access to various sections for maintenance. The entire housing shall be mounted on extruded aluminium channel frame work having pressure die cast aluminium jointers.

#### **4.4 TANK**

Tank shall be constructed of 304 grade 1mm thick stainless steel with necessary slope on both sides to facilitate fast removal of drain water. The tank shall extend over the cellulose pads. This tank shall be of sufficient cross-sectional dimensions to hold a large quantity of water. The design shall allow sufficient and easy access for cleaning the tray. The tank shall be provided with suitable connections to connect the water circulating pumps to circulate water to the pads. Make up water arrangement provided shall be complete with a float valve to maintain the water level in the tank.

#### 4.5 **MOTORANDDRIVE**

Fan motors shall be 5 HP,  $415 \pm 10\%$  volts, 50 cycles, 3 phase squirrel cage, totally enclosed fan cooled with IP-55 protection. Motor shall be specially designed for quite operation and motor speed shall not exceed 1440 RPM. Drive to fan shall be provided through belt drive arrangement. Belts shall be of oil-resistant type. Adjustable sheaves shall be provided. The make of motor shall be Crompton/Kirloskar/Bharat Bijli/Equivalent.

#### 4.6 **FAN**

The fan shall be DIDW type centrifugal fan forward, curved complete with motor and drive package. The wheel and housing shall be fabricated from heavy gauge galvanized steel. The fan impeller shall be mounted on a solid shaft supported to housing with angle iron frame and pillow block heavy duty ball bearings. The fan shall be selected for a speed not exceeding 1000 RPM. The impeller and fan shaft shall be statically and dynamically balanced. The fan outlet velocity shall not be more than 9.5 M/Sec. The fan housing with motor shall be mounted on a channel base mounted inside the housing on anti-vibration springs mounts. The fan outlet shall be connected with casing through fire retardant canvass. The make of fan shall be Kruger/Nicotra/Equivalent.

#### 4.7 **CELLULOSEPADS**

The pads shall be cellulose paper pads of suitable thickness to provide at least 90% saturation efficiency. The Cellulose paper pads shall be housed in a galvanized steel casing complete with water distribution header and interconnecting heavy duty G I or PVC pipes between pump and distribution header.

#### 4.8 WATER CIRCULATIONPUMP

Water circulating pump shall be of mono-block type heavy duty. The suction portion shall be at the bottom with proper seal arrangement to directly pick up water from the tank. The pump shall be suitable to operate on 220 volts, 50 cycles, single phase AC supply.

#### 4.9 **FILTERS**

Each unit shall be provided with a factory assembled filter section containing washable aluminium wire mesh filters having aluminium frame. Filters media velocity shall not exceed 2.5 M/Sec. Filters shall fit so as to prevent by-pass. Holding frames shall be provided for installing a number of filter cells in banks. The housing shall be made from aluminium sections. All joints shall be sealed airtight. The filter loading mechanism shall be sliding type.

#### 4.10 ISOLATORS

Vibration isolators shall be provided with all air washer units. The fan and motor framework shall be isolated from the air washer framework by means of spring type vibration isolators. The framework of the air washer and the floor shall be isolated by means of neoprene vibration isolation pads of size 150mmx150mm in two layers.

#### 4.11 INSTALLATION

The pumps & air-washer etc. shall be provided with necessary vibration isolation cushy foot mounts. The company shall arrange all necessary accessories such as nut bolts etc. The company shall arrange his own labour with material for completion of assembly. Anti-vibration pads of adequate efficiency shall be provided.

#### 4.12 **GUARANTEE**

The guarantee of the air washer unit is **ONE** year from the certified date of completion of work against any kind of defects or fault i/c all major & minor consumables (fan, motor, pulley,belts, filters, pump etc.) installed in the unit.

#### **4.13 BUY BACK**

#### **TERMS & CONDITIONS**

#### 5. TERMS & CONDITIONS GENERAL:

- 5.1 The Contractor shall **commence supply, installation and commissioning of Air Washer Unit** at Madhyanchal for Government of Madhya Pradesh within 07 days from the date of issue of acceptance and completed within 30 days.
- 5.2 The Contractor shall completely indemnify and hold harmless the Client and its personnel against any liability, claims, losses or damages sustained by it or them by reason of any breach of contract, wrongful act or negligence by the Contractor or any of its personnel engaged in the provision of the Air Washer unit work to the Client.
- 5.3 The Contractor shall not Sub-Contract or Sub-let, transfer or assigns the contract or any other part thereof. In the event of the contractor contravening this condition, Client shall be entitled to place the contract elsewhere on the contractor's risk and cost and the contractor shall be liable for any loss or damage, which the Client may sustain in consequence or arising out of such replacing of the contract.
- 5.4 The contractor shall have to maintain the work for **ONE**-year guarantee period from the certified date of completion. In case, the problem exists in such place/area the contractor shall provide the service without any claims/charge in such cases.
- 5.5 The bidders are advised to visit/examine the site on any working days between 11:00 AM to 5:00 PM before quoting the Rate.
- No escalation in any form either of cost/materials/labours or any taxes shall be payable by the M.P. Bhawan Authority during the guarantee period.
- 5.7 The rates mentioned in the financial bid shall be inclusive of all Packing, Forwarding, Cartage, Insurance, Loading-unloading, road permit/state entry permit and Delivery, Installation, Testing, Commissioning, etc complete at site including temporary constructional Storage, Risks, Overhead Charges, General Liabilities/ Obligations etc. Any variation in the above said components till the completion of the work will also be in the bidder's account.
- 5.8 The agency shall carry out quarterly visit/inspection/maintenance (if required, with prior approval of Engineer-in-charge) of entire system and attend un-limited calls/break-down calls during the guaranty/warranty period. Thoroughly check/service entire system two times in a year with prior approval of Engineer-in-charge.
- 5.9 The bidder shall be solely responsible for any accident/medical/health related liability/compensation for the personnel deployed by it at Madhyanchal. The Madhyanchal shall have no liability in this regard.
- 5.10 On completion of all work, bidder shall remove all surplus materials & leave the site in a broom clean condition, failing which the same shall be done at bidder's risk & cost.
- 5.11 Bidder shall be responsible for taking/disposing off the all old dismantled waste materials away from the campus. The disposal of such materials shall be done immediately after completion of work at own risk & cost.
- 5.12 Conditional tender, tenders received without Tender Fee & EMD will not be accepted.

#### 6 MINIMUM ELIGIBILITY CRITERIA

6.1 The Bidder should have experienced in the similar field not less than tender amount in the Government Departments / Public Sector (Central or State) /Three Star Hotels / Guest Houses or equivalent of any three years during last five years.

(Relevant documents i.e. copy of work order &receivedsuccessful payment/transactiondetails or completion certificateto be submitted along with bid as documentary proof.)

- 6.2 The Bidder should be registered with GST portal and must submit the attested copy of provisional GSTIN registration certificate.

#### 7. PENALTY

- 7.1 Whenever and wherever it is found that the work is not up to the mark, it will be brought to the notice of the Contractor by M.P. Bhawan Authority and if no action is taken within 24-hour, liquidated damages @ ₹ 500/- per complaint shall be imposed. The decision of M.P. Bhawan Authority official in charge shall be final, in this regard.
- 7.2 The contractor shall ensure immediate rectification of such complaints in the guarantee period, within twenty-four hours failing which a minimum penalty of ₹ 500/- per day will be imposed beyond reasonable time and will be deducted from the pending bills or the cost of security deposit of the contractor.

#### 8. DISPUTE SETTLEMENT

- 8.1 In the event of any dispute all matter shall be referred to the sole arbitration of Resident Commissioner, Govt. of Madhya Pradesh, M.P. Bhawan, New Delhi, for arbitration, whose decision shall be final & binding.
- 8.2 All disputes arising out of or in any way connected shall be deemed to have arisen in New Delhi. Only the courts in New Delhi shall have jurisdiction.

#### 9. TERMINATION OF CONTRACT

The M.P. Bhawan will have the right to terminate the contract by issuing 30 days' notice if it is felt that the services rendered are not satisfactory or there is a delay in rendering service. The Security Deposit shall be forfeited and all payments shall be withhold till finalisation of account.
